2. **Minutes of Previous Meeting** Secretary Lori Heimbürger read the minutes of the General Membership meeting from Sept 9 2023. Kent made motion to accept minutes as presented. Reggie Wellman 2nd. Motion passed. Will be posted to website.

Memorial Day Weekend Report - Bertha Lake Property Owners Assn., Inc.

Professional Lake Management (PLM)

Bertha Lake and Shingle Lake were "Surveyed" and chemically treated for Algae Blooms on Wednesday, May 08, 2024. Then Bertha Lake and Shingle Lake were chemically treated for invasive weeds (*Eurasian Water Milfoil* and *Curly-Leaf Pondweed*) on May 20. It is likely that both lakes will require another treatment for Algae Blooms in a couple weeks. Lake George was treated at the southerly channel with MD Pellets (Muck Treatment) on May 06, and will be surveyed on June 03. Chemical treatment for Invasive Weeds and Algae will take place on/or about June 10, along with another MD Pellet treatment at the channel. This date depends on the weather of that day.

It should be noted that each of these three lakes has its own Special Assessment District to assess funding for these treatments, as well as for some other limited Lake Maintenance and Improvement tasks. The way Bertha Lake SAD is set up is a fixed amount, each year, and at this time, we are pretty close to even, as far as revenue v. expenditures. Shingle Lake and Lake George SAD's are set up slightly differently with an amount that can vary, but tops at \$ 125.00 per year, per qualified parcel. Since we are currently working on next year's budget, we are seeing that Shingle Lake is just a bit ahead of the game, and we may drop next year's rate from \$ 125.00 to around \$90.00, but we won't know for sure until we see the "forecast" from PLM. Lake George may also see a slight decrease from \$ 60.00 to \$ 55.00, and maybe even \$ 50.00. The final decision on this will be made during October, 2024.

Curb Side Rubbish Pickup and Recycling

It is likely we will see a slight increase in Rubbish Assessment this year, from \$ 150.00 or year, to \$ 160.00 per year. This will be on your Winter Tax Bill, and, again, the decision will not be made until we are able to see projections for the year, in October.

Also, just an advisory....while we welcome cardboard boxes in our recycling dumpster(s), PLEASE consider breaking the boxes down. The fully formed boxes take up a lot of room very quickly in those bins.

The compost site is open on Wednesdays, Fridays, and Sundays starting at 9 a.m. If there is only slight traffic, they will close around Noon, but if its busy, we can keep them open a little later, or you may call any of the Trustees to see about borrowing a key if you need access on an off day. Please note that the compost site is for leaves, bundled sticks, grass clippings etc. For some branches we have limited disposal - a burn pit. With regard to leaf pickup, that season started May 1 and will last for appr. 5 or 6 weeks, and then start again on about November 1, again, for 5 or 6 weeks.

Spongy Moths (or Gypsy Moths)

Aerial Spraying for Gypsy Moths was performed on Thursday & Friday, May 23 & 24, 2024. This is funded by a County-wide Millage, that is renewable (at the election) every three (3) years. That amount is 1.0 mills is included on the Winter Tax Bill. This year the more highly concentrated residential areas of the Township [by population] were included in the treatment, including the neighborhoods around White Birch, Bertha Lake, Silver Lake, Lake George and Shingle Lake. There was also some small concentrations treated on Jackson Avenue and on Monroe Road. We need YOUR help !

We have three problems that seem to be increasing, that we would like to, instead, reduce. The **First** has to do with your normal mailing address. People occasionally move, and never let us know. We then have no way of knowing where to send your mail, like, for instance Tax Bills. In the past couple years, we are receiving 120 to 150 Tax Bills back for "Bad Address Return". This also applies to "Notices of

Assessment Change and Paid Tax Receipts. We have no idea what to do with them, but we can usually look forward to a pissed-off person calling and trying to make it our fault that their late or unpaid taxes now have an interest charge, or that they didn't have their opportunity to Appeal to the Board of Review. So, don't forget to update your address, with us. **Second**, is phone messages. So, you leave us a message to call you back, but when we try to call, we get: "Sorry, the customer has not created a voice mail box", or, "Sorry, the customer's voice mail box is full." Please.....we all know that phone is within arms reach, sticking out of your pocket, so take it out, and if it says Lincoln Township in the Caller ID, please considering answering. **Third**, Please don't wander around when you are talking on the phone. It keeps cutting out, and sometimes it even cuts off. That makes it hard to figure out what problem you want us to solve. So, please be considerate.....Plant your feet and stay there while you are talking!

Boating Information

The website for the Michigan Department of Natural Resources has lots of information regarding Boats. Everything from Marine Safety and Marine Law to places to visit, to proper licensing. Far more than I could ever hope to repeat, here. There will be a new "tab" on their website, soon called "Sustainable Boating". Watch for that, it will talk about cleaning boats/trailers. There is one thing, though I would like to emphasize, and that is boat cleaning for Invasive Species. While there is a lot of information out there, such as the possible penalties for "getting caught" transporting invasives from one lake to another. They always seem to forget to mention what an appropriate cleaner is for your boat and trailer. The top three cleaners are "Aquatic Virkon", "Formula 409", and "Bleach". This not only applies to the hull of the boat and the hard surfaces on a trailer, but also bilges, ballast tanks, coolers, ski boots, and anything that might hold even a little bit of water. Bertha Lake, Shingle Lake and Lake George are all fortunate that we are surrounded by densely populated Oaks. The leaves that fall or blow into the lakes degrade, partially, into an acid that significantly lowers the pH of the water. This helps prevent various critters, such as mussels from forming a viable population in the Lake. Silver Lake, on the other hand, does NOT have such a dense Oak Population and

they do have Zebra Mussels, but not Quagga Mussels, yet. So, if you are visiting other lakes, take a few minutes and clean your boat and trailer off, and do the same when you return to our lakes. By the way, that acid (Tannic Acid) is also what leaves the line on your hull or on your pontoons.

There is a lot of chatter about "Wake Boats". And, YES, there are legislative proposals that would regulate and restrict their use on smaller lakes. However, these proposals have not as of yet, received even a Committee Hearing, and best guess is that even if some piece of legislation comes to the floor(s) it won't be this year until after the General Election. So, probably nothing will change, this season.

New "Stuff" in the Township

Hopefully, by the time these meetings occur, we will have a New Fire Truck. Paid for, in large part, by a grant, with the Township qualifying for a low interest loan for the remainder of the bill....it is a new pumper truck with a cost of a little over \$ 400,000.00. It is replacing a truck that is over 20 years old, and, in fact, is already sold to another Fire Department in (I think) Arkansas. *It came in on Wednesday May 22, 2024*

In June we will be considering bids to build a new Pole Barn for equipment & tool storage, probably at the Compost Site. It will be 32' x 40' and we expect it to cost around \$ 40,000, again partially paid for with a grant.

We have been offered the opportunity to acquire the old School House on Arthur Street - "free-of-charge", except of course we will have to pay for the transfer and paperwork. Several years ago, Stephenson-Wyman Funeral Home in Clare purchased it with the idea of having a sort of drive-thru chapel...that is, a place where funeral attendees could get in out of the weather if needed. Larry Wyman decided to not pursue that idea and has offered the building and grounds to the Township. It is a solid building but it needs a roof, windows, and some cleanup, electrical and plumbing work. The Clare County Treasurer has some money from the County's Land Bank sales that she may consider giving to the Township, in the form of a grant, in order to help restore the building. We're not sure what the building would be used for, but there are lots of ideas: Library, Room for smaller meetings, Wi-Fi – Internet cafe, Yoga-Pilates Room, etc. We are still working on that one, so if you have any ideas, now would be a good time.

Septic Systems

Michigan is the only State that does not have Septic System regulations. This is something that has been talked about, in Lansing, for a long time. At this time, there are four (4) pieces of legislation that would create a State-Wide set of regulations for, at

least the periodic inspection of Septic Systems. Two of them are in the House and Two of them are in the Senate. It is very likely that some action will happen this year, toward passing something. SO WHY ? One of the most simple and inexpensive tests for properly functioning systems is an e-coli test (*Escherichia coli*). For most people e-coli may give you a tummy ache or it might give you all the symptoms of a serious flu. However, e-coli signals the possible presence of many other pathogens that can kill you, including: *Cryptosporidium, Legionellae, Giardia, Cholera, Hepatitis, etc.* e-coli is what the Health Department tests for at Swimming Beaches. So, where does e-coli come from. It exists in the gut of all warm-blooded critters. To get into our lakes and streams, it is generally accepted that the primary sources.....the top four (4) are: Leaking or failed Septic Systems, Waterfowl and run-off from Wild Animal Habitat, Agricultural Run-off, and Municipal Water Treatment Plant overflows. A properly functioning Septic System gathers the effluent into a tank, where it breaks down to a fluid, then drains into soils that complete the degrading process, usually in a drain field of some sort. Leaking tanks and clogged drain fields become a problem. In addition to that problem, densely populated areas, without municipal systems, but with a lot of septic systems, compound the problem. So, what are some of the high points (Yes, I have my favorites, but not all):

\$ 500.00 for an inspection. That was the first thing they thought of. Never forget Lansing has a worse addiction to "one size fits all" than the addiction of the worst Heroin User in History. Why would an inspection in Clare County cost as much as, say, Oakland or Washtenaw County?

How often is the inspection ? Some say every three years, some say five years. The Realtor's Lobby says anything EXCEPT at the "Point-of-Sale"

What will they inspect ? Not clear. I guess a guy comes out, digs up the lid, sticks his head in the hole, and determines if everything is good or bad. Just make him comb his hair before you let him in the house, okay ?

Who will be qualified and how, to do an inspection ? The State is already designing a licensing and certification program, along with fees for that license or certification. Ever notice there are two reasons for licenses in Michigan? One is a revenue stream, and the other is so they can take that license away.

There are lots of other questions, but three notes, here: 1. There are currently 11 Counties in Michigan that have inspection guidance on Septic Systems; 2. Some of those regulations DO call for Point-of-Sale inspections. 3. The proposed State legislation mandates that these County's Ordinances "go away".

Roads

A number of projects are happening, this year. Old State Ave. Should be finished this year (paving) which will make a paved road all the way from M-61 to Farwell. Monroe Rd. (2 miles) will be paved hopefully, this year. Both of these projects use Asphalt Millings, ground up at other projects, tire chips are added, then soy juice is added to soften the millings, then once 'down' the road is sealed. They say, these are then the only roads in the world that are edible. Also having an Ultra-thin layer of new pavement on Bringold and Ashard (to the Gas Plant), and on the Lincoln Road approach, New Gravel on Jackson, and on Bringold near South of Browns, and a new overlay on Shingle Lake Drive and some other small gravel projects near trouble spots.
